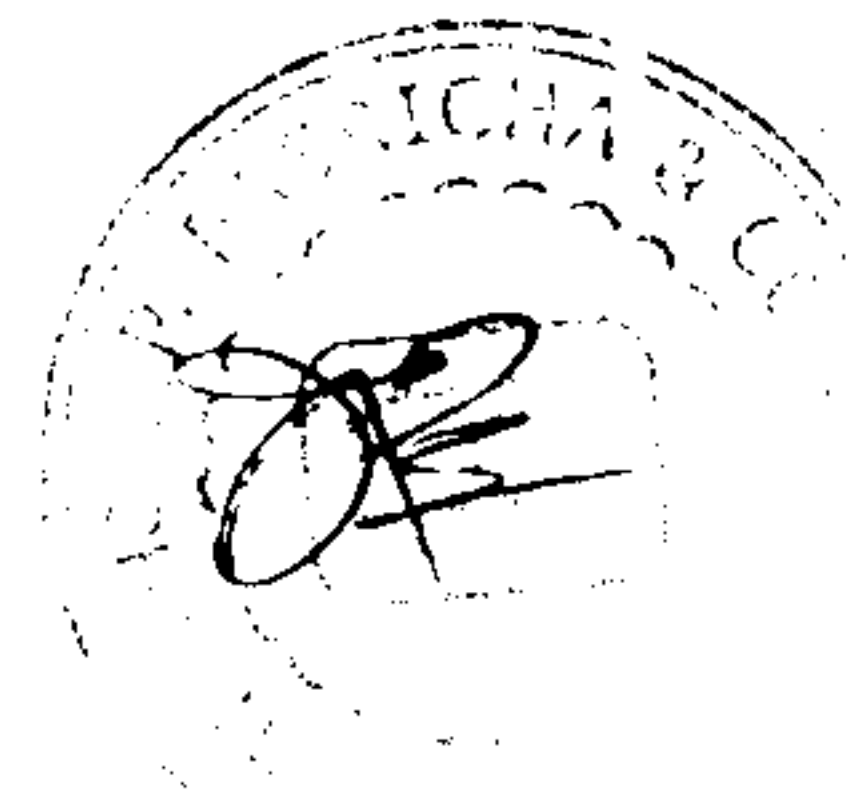
**AUDITORS' REPORT**

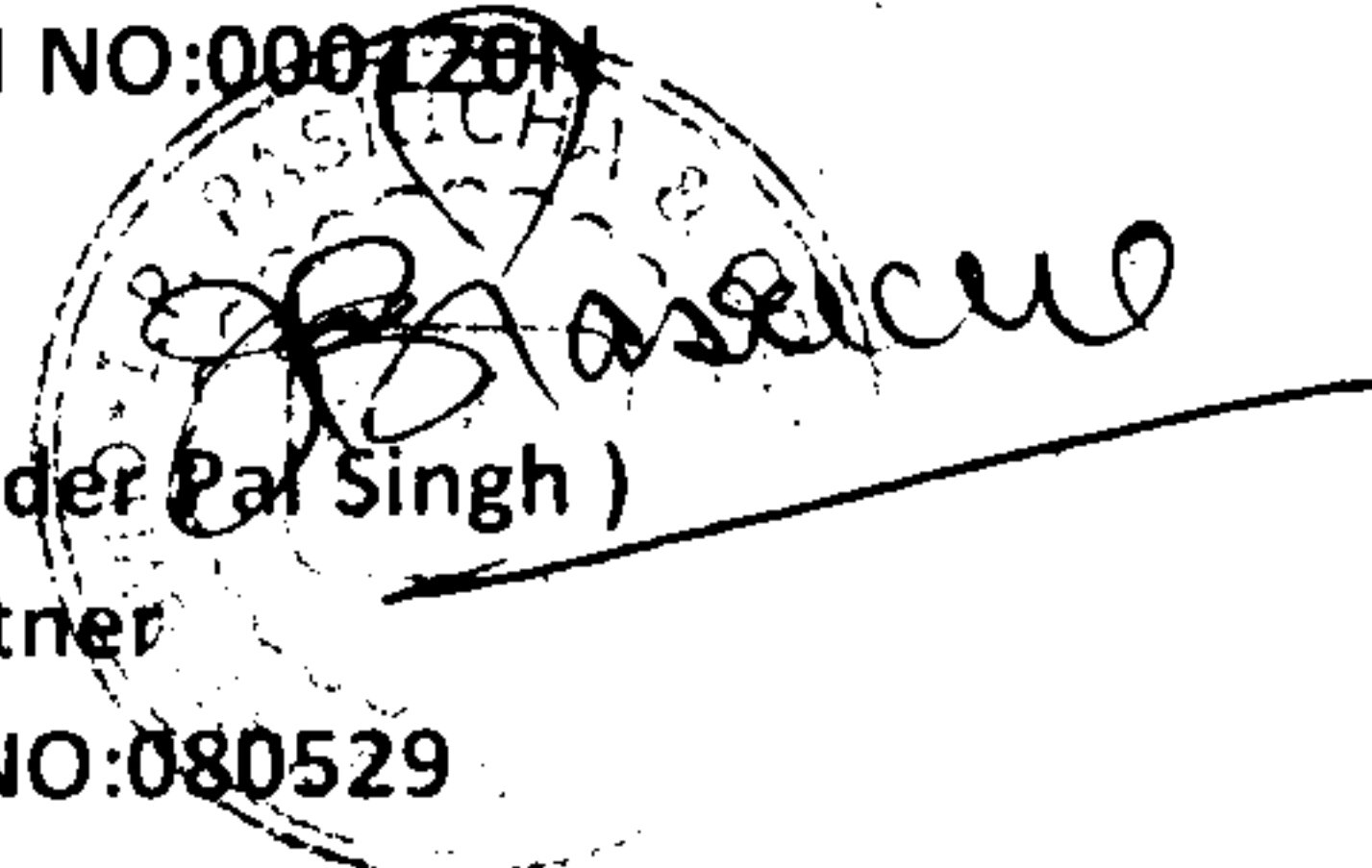

**Significant Accounting Policies**

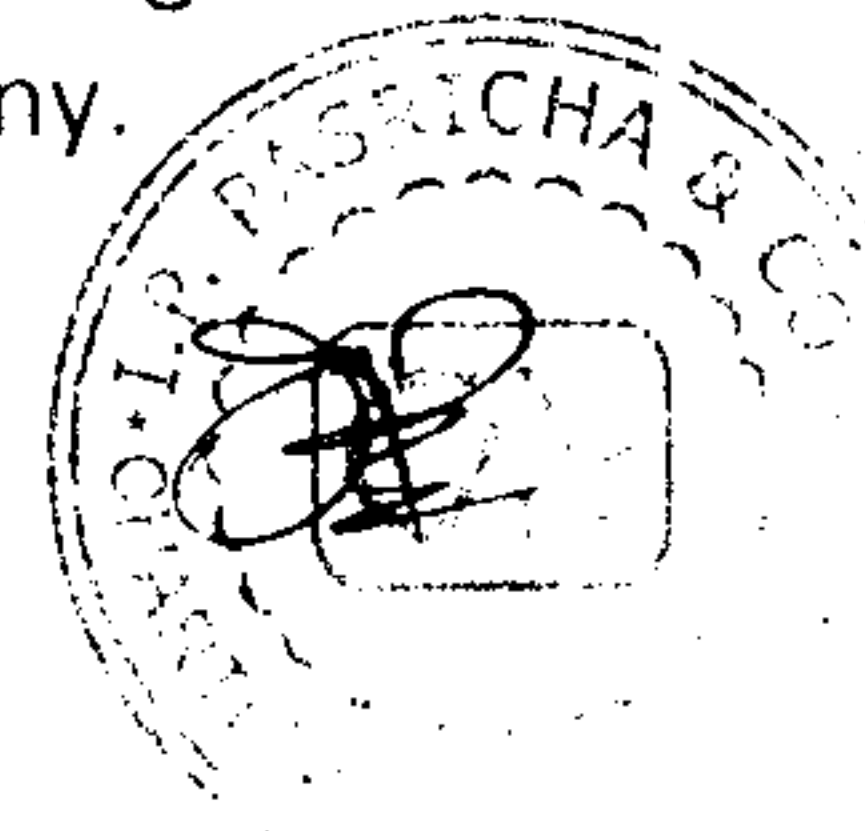
